

**RESOLUTION 19-192**

**A RESOLUTION ADOPTING THE FINAL MILLAGE RATES  
FOR FISCAL YEAR 2019-2020**

WHEREAS, the Board of County Commissioners of St. Lucie County, Florida, has made the following determination:

1. On September 5, 2019, after TRIM notices were mailed to all property owners pursuant to Section 200.069, Florida Statutes, the Board of County Commissioners (sitting as the Board of County Commissioners, the Mosquito Control Board, and the Erosion Control Board) held a public hearing to consider adopting the tentative millage rates for fiscal year 2019-2020 and adopted the tentative millage rates.
2. On September 19, 2019, after notice published in the Tribune on September 14, 2019, the Board held a Public Hearing and adopted the Final Millage for fiscal year 2019-2020.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Lucie County, Florida:

- A. The following are hereby adopted as the final millage rates for fiscal year 2019-2020:
