

**RESOLUTION**

**A RESOLUTION ADOPTING A FINAL BUDGET  
FOR FISCAL YEAR 2020-2021**

**WHEREAS, the Board of County Commissioners of St. Lucie County, Florida, has made the following determination:**

- 1. On September 10, 2020, after TRIM notices were mailed to all property owners pursuant to Section 200.069, Florida Statutes, the Board of County Commissioners (sitting as the Board of County Commissioners, the Mosquito Control Board, and the Erosion Control Board) held a public hearing to consider adopting the tentative budget for fiscal year 2020-2021 and adopted the tentative budget.**
- 2. On September 24, 2020, after notice published in the Tribune on September 19, 2020, the Board held a Public Hearing and adopted the Final Budget for fiscal year 2020-2021.**
